General Terms and Conditions

§1 Scope and Contracting Parties (1) The following General Terms and Conditions ("GTC") are part of every usage and partner contract between Salus Global Club LTD Trust Company Complex, Ajeltake Road Ajeltake Island, Majuro, MH96960 Republic of the Marshall Islands Registration number: 132515 (hereinafter referred to as "Salus") and any natural or legal person who registers as a user or distribution partner. (2) By completing the online registration in the Salus Global back office, these terms are legally accepted. (3) Salus offers access to external systems in the areas of automated copy trading, physical precious metal protection, and digital club tools via its digital platform. The platform is intended exclusively for business users (no consumer contracts).

§2 Role of Salus and Structure of Third-Party Providers (1) Salus Global Club LTD is not a broker, financial service provider, payment processor, or asset manager. (2) Salus provides a technical platform through which registered users gain access to the following third-party providers:

Al TradingPilot LTD (Marshall Islands) Provider of automated trading systems GOLDRIVE AI, MONEYDRIVE AI

tegasFX Regulated broker handling all trading activities (Payment in USDT, USDC or via SWIFT transfer)

Auvesta AG (Germany) Specialized in the purchase, storage and sale of physical gold and silver

- (3) Contractual, deposit, and trading relationships exist solely between the user and the respective third-party provider. Salus is not involved in any financial flow and never manages customer funds. (4) For the European area, Salus reserves the right to use licensed external service providers based in the EU for technical, logistical, or payment-related tasks. These are not explicitly named as no direct contractual relationship with the user exists.
- §3 Registration and Start of Contract (1) Using the platform requires personal registration in the Salus digital back office. Registration is only permitted for legal entities, partnerships, or natural persons over 18 years of age acting in a business capacity. (2) A usage contract is concluded upon successful registration. Acceptance of these GTC is mandatory and confirmed by checking the appropriate box or submitting the registration form. (3) The user agrees to provide complete and truthful information during registration and to update any changes immediately. (4) Platform use is at the user's own risk. Salus reserves the right to reject registrations without stating reasons.
- §4 Risk Notice and No Guarantee of Success (1) Participation in automated trading systems (copy trading, forex trading) via AI TradingPilot LTD and the broker tegasFX involves

(2) Past performance is no guarantee of future results. Neither Salus nor any third-party providers guarantee any specific return or capital development. (3) Each user acts at their own risk. It is solely the user's responsibility to assess their risk tolerance, available capital, and financial situation. Never invest money you cannot afford to lose. (4) The systems offered are no substitute for personalized investment advice, tax consulting, or legal assessment. §5 Disclaimer of Liability (1) Salus is not liable for losses, damages, or technical issues resulting from the use of third-party providers or their systems, particularly:

- Market developments, spread fluctuations, or unexpected events
- Trade execution delays or payout delays
- Errors in KYC processes, verification, or access to third-party systems
- Misuse of login data, wallets, or broker accounts by third parties
- (2) Salus is only liable for intentional or grossly negligent conduct. Liability for simple negligence is excluded except in cases of injury to life, body, or health. (3) All contracts with third-party providers are governed exclusively by their terms and conditions. Salus assumes no responsibility for the content, pricing, terms, or services of external partners.
- §6 Contract Duration and Termination (1) Registration with Salus Global Club LTD is open-ended. (2) Users may cancel their access at any time without notice by sending written notice (e.g., email to support@salusglobal.club). (3) Salus reserves the right to deactivate or delete user accounts in cases of:
 - Violation of these GTC or applicable laws
 - Intentional manipulation, fraud, or misuse of the system
 - Harm to third parties caused by the user's behavior
- (4) Upon termination, all rights to use the platform and related structures (e.g., partner network, commissions, career level, back office access) expire.
- §7 Communication, Data Use, and Technical Handling (1) By registering, you agree that Salus may use your personal data (e.g., name, email, phone number) for internal communication, support, and system operation, including:
 - Status updates regarding career and commissions
 - System notices and technical information
 - Information about new products or features
 - Invitations to webinars, promotions, or events
- (2) Salus only works with trusted technical partners for data processing. Data is shared only as needed to fulfill the contract (e.g., payment providers, hosting, email communication). (3) For European business, Salus may use licensed EU-based providers for payment processing, logistics, or support. These companies act on behalf of Salus but are not contractual parties to the user.

§8 User Duties and Ethical Behavior (1) You agree to comply with applicable laws, fair business conduct, and third-party rights when using the platform. (2) Specifically prohibited are:

- Misleading promises regarding income, profits, or guaranteed results
- Use of aggressive sales tactics or psychological pressure
- Advertising with unauthorized health or healing claims (e.g., "cures cancer")
- Publishing unauthorized landing pages, product sites, or logos
- System misuse to manipulate career levels, commissions, or structures
- (3) Distribution partners may not offer Salus products via platforms such as Amazon, eBay, Alibaba, etc. Sales may only occur via the official platform and personal back office. (4) Any attempt to recruit other distribution partners from different lines (crossline sponsoring) is strictly prohibited.

§9 Usage Rights, Trademarks, Domains (1) Salus grants a simple, non-transferable usage right for:

- Your personal back office access
- Your replicated system (partner link)
- ClubPilot AI, if actively booked
- Use of marketing materials from the official back office
- (2) It is prohibited to create brands, domains, or social media pages suggesting an official affiliation with Salus without written approval. (3) Trademarks such as Salus Global Club, ClubPilot AI, AI TradingPilot, SwitchPilot, GOLDRIVE, MONEYDRIVE may not be used in domains, profile names, product names, or paid ads without explicit approval.
- §10 Governing Law, Jurisdiction, Severability (1) The laws of the Marshall Islands apply, excluding the UN Convention on Contracts for the International Sale of Goods (CISG). (2) The place of jurisdiction for all disputes related to these GTC is Majuro, Republic of the Marshall Islands, where legally permissible. (3) Should any provision of these GTC be wholly or partially invalid, this shall not affect the validity of the remaining provisions. Invalid clauses shall be replaced by valid ones that best reflect the original purpose. (4) Amendments or supplements to these GTC must be made in writing. Salus reserves the right to update these GTC at any time. Changes will be communicated via the back office. Continued use is deemed acceptance of the updated terms.
